Contractual Terms

The Interment Rights Holder has the right to cancel the contract within 30 days of purchase, if not used, and St. Mary and St. Stanislaus Kostka Cemeteries will refund all monies paid at the time the contact was signed. Public Resale of Burial Rights by Interment Rights Holder at St. Mary Cemeteries and St. Stanislaus Kostka is prohibited. A Rights Holder is only permitted to resell their “unused” Interment Rights back to St. Mary and St. Stanislaus Kostka Cemeteries, as stated in St. Mary and St. Stanislaus Kostka Cemeteries By-laws. In such an event, St. Mary and St. Stanislaus Kostka Cemeteries will repurchase these rights at the rate shown on the current Tariff of Rates and not the Care & Maintenance paid. An administration fee may be applied to the transfer of a lot.
